## Dear Neighbors,

Since the deadline for boards and commission applications is Friday, and I want YOU to consider applying, I'm sending this out a day early. Here's what's happening in this busy month.

1. **Heart of Golden-** This is the <u>redesign of the 7+ acre city owned land east</u> of Ford Street and on both sides of 10th street replacing the Miller/Coors office building with municipal uses. It is HUGE, and will be a decades long impact on Golden. A virtual meeting will be held on <u>March 1<sup>st</sup></u> (see register link) at 5:30pm and an In-person meeting is scheduled for March 9th at 5:30pm in City Council Chambers, both meetings are opportunities to provide feedback on the latest plan for the corridor.



**2.** CoorsTek Redevelopment - Five City Blocks, downtown redevelopment. That is also HUGE. Now that the <u>application for zoning change</u> is at planning commission I am unable to comment. But YOU CAN. Due to some good public input so far, the

applicant has requested a delay until April 6th of their hearing. There will be opportunities during March to participate in a public dialog about this space. Please realize that this is not a pro-forma process from my perspective. It is a chance to provide your opinions and potentially have them impact how this property is developed over the next 10 years or so. I assume the link to the application will be updated with details.

- **3, Boards and Commissions** Please consider <u>applying to open positions</u>. The deadline to apply is March 4th, with interviews on April 5th. <u>Here are the open positions</u>. If you have applied or have questions about the commitment, <u>please let me know</u>.
- 4. Building Codes and Zoning Let me be clear about my views, I support the direction of the new Form Based zoning code. Watch a fewer than three minute video I made on how to provide your input. You can still provide input. The timing looks like trying to adopt in late April to May timeframe.
