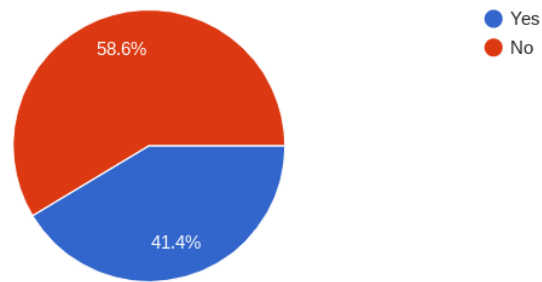

2. Sugary Drinks - I voted to support the change in menu offerings on sugary drinks in combined kids meals. On 1/25 city council passed this rule which will be enforced in early June. The quick survey I carried out was not in favor of passage. Yet, I voted for it. See this blog post for the rationale I had for this decision.

3. **Boards and Commissions** - I serve, with Paul Haseman, on the Boards and Commissions subcommittee of city council. A subcommittee is formed of two councilors, and one city staff person, and we're able to work to improve whatever is our mandate. Paul and I have met and are hoping to improve the on-boarding process of new board members. But we can only do that if people apply to open positions. The deadline to apply is March 4th, with interviews on April 5th. Here are the open positions. Please note, some current members will reapply and their experience will be weighed into selection decisions. I learned a ton and met some great people on Planning Commission from 2012-2020. I'd recommend being on a B or C!

4. **Protecting and Preserving Affordable Housing** - See this article from the Golden Transcript on how the City of Golden, among others, is trying to keep residents in the Golden Hills Mobile Home park housed.

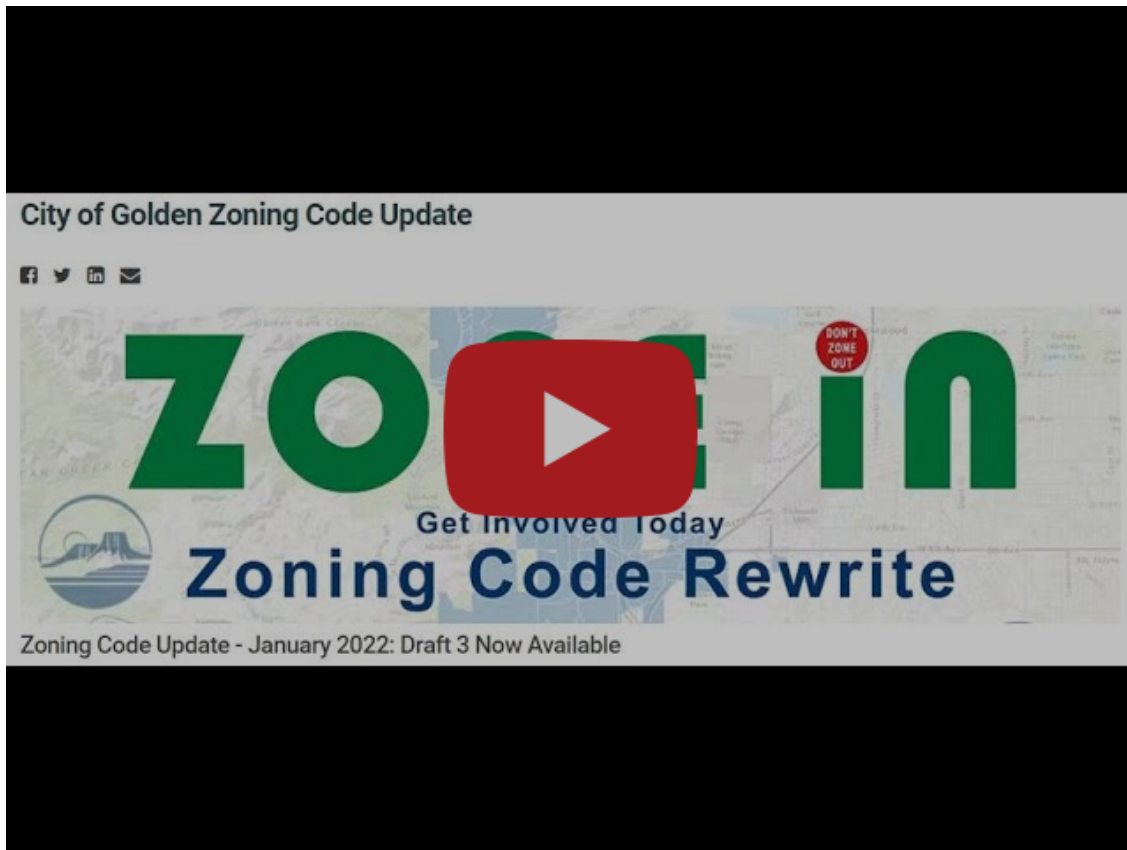
